Written announcement must be received in the designated judge's office by 10:00 a.m., July 6, 2020. The written announcement may be delivered by mail, facsimile, e-mail, or hand delivery. Oral announcements and announcements by telephone will not be accepted.

Failure to make a written announcement to the said judge as and when herein above provided, may, in the court's discretion, subject the offending counsel or pro se party to the sanctions provided for in subsection (a) of U.S.C.R. 20.

Whether a case shall be placed on the pretrial calendar or trial calendar shall be solely within the discretion of the court, regardless of what announcement is made (U.S.C.R. 8.1).
